Always there for each other

It was a gorgeous afternoon, the sun was shining, and spring was in the air when I visited Dick and Bette, both 84 years old, and new Meals on Wheels participants.

Dick and Bette first met in the 1st grade. Born in 1928, they grew up in Illinois and went all through school together. "Our fathers worked together, so we basically grew up together. We went to all the school dances and spent most of our weekends together." Dick entered the Army at the age of 18 and was deployed to Korea. While he was gone, Bette moved to San Pedro, California, to start a new job.

Dick returned from Korea in 1947, and Bette promptly moved back to Aurora to be near him again.

They were married one year later, settled down and had their first son, Michael, in 1950. In 1955, Bette suggested they move to San Pedro, where their second son, Richard, was born.

Dick worked for the Los Angeles Police Department as both a motor officer and in the personnel division. He stayed home with the boys in the evenings while Bette worked as a receptionist for Kaiser Hospital. They played golf and spent time outdoors with the boys. "We were always on the go," says Dick.

"As the kids grew up and out, we began traveling." Dick retired in 1979. Their travels took them to Southeast Asia, Europe, and Hawaii. They eventually built a home in Arnold, California, and lived there for 21 years. In 2000, when they began having medical problems, they moved to Brentwood, and continued to play golf and enjoy community activities.

Last autumn, Bette fell and broke her hip and femur. Afterwards her balance was never quite the same. She had several more falls this past winter and landed in the hospital at least 8 times. Bette not only lost her mobility, she also lost her appetite.
