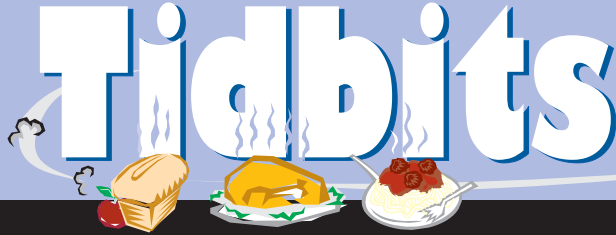

Eighty-six year old Bea wasn't always dependent on others. In earlier days she was a train-blazing woman who worked most of her life as a secretary because she enjoyed the challenge of a career. Even today she is proud of her accomplishments and will eagerly tell you about how she used one of the world's first computers!

Unfortunately, recent hardships have made life difficult for Bea, reminding us that even the strongest people grow older and fall victim to terrible misfortune.

Tragedy struck 12 years ago when her beloved son passed away unexpectedly. The experience tested Bea physically and emotionally. "The most painful thing to go through is a child's death," she says. Then, six years later, still mourning the loss of her son, Bea lost her husband, too. Suddenly

alone, the money she and her husband had put away for retirement deteriorated rapidly. That's when she contacted Meals on Wheels of Contra Costa, and we have proudly served her ever since.

It's a good thing we're here for Bea. In addition to diabetes, thyroid problems and blood cancer, Bea can no longer hear. Determined to communicate with others, Bea taught herself to read lips—but now, her eyesight is failing, too.

Her ailments make life more challenging every day. She can no longer cook because she has trouble standing, and her failing eyesight means she can no longer drive.

These days this once vibrant, ambitious woman rarely leaves home.

"If it weren't for Meals on Wheels of Contra Costa, I don't

know where I would get my next meal. Thankfully, the volunteer come to see if I'm still alive."

Meals on Wheels of Contra Costa knows that we must remain strong as Bea grows more frail—and we will be here for her for as long as she needs us.

Confessions of a planned giver

Dorothy H. recently shared: "The reason I became a planned giver to Meals on Wheels is two-fold. First, I was born and raised in Contra Costa County. In fact, my father graduated from Mt. Diablo High School, where I attended, and was an elected official of Concord for a number of years. Not surprisingly, I feel a deep commitment to my native county and want to give back to it what I can. My mother was a driver for Meals on Wheels. I went with her many times and walked the food up to the door myself! I'll never forget how great it felt to do something that was easy for me, but so appreciated by the elder members of the hometown I loved so much.

Sample language that can be used when making a bequest to Meals on Wheels of Contra Costa

"I give, devise, and bequeath to Meals on Wheels of Contra Costa, Inc., federal tax identification number 68-0231350, P.O. Box 3195, Martinez, CA 94553, the sum of \$_____ (or describe the real or personal property or portion of the estate) to be used for its general purposes, including its delivery of nutritious meals to frail and elderly neighbors."



A special way to help...

Answers to your questions about leaving a bequest to Meals on Wheels of Contra Costa

Q What is a bequest?

A A bequest provides a specific amount of money, a percentage of an estate, or a certain piece of property to a charitable organization at the time of death. For most people this involves naming a charity as a beneficiary in a will, codicil, life insurance policy or retirement plan or by making a gift of real estate.

Q What is the benefit of making such a gift?

A Often a planned gift offers a charitable-minded person the chance to leave a special legacy without compromising his or her current financial situation. Some planned gifts can offer immediate tax benefits during life as well.

Q Is it difficult or complicated to leave a planned gift?

A Typically no. The first step is to contact an attorney who can advise you on setting up a gift that ensures your wishes are followed. Sample language is provided on the opposite page which should make the process even easier.

Q Why does Meals on Wheels of Contra Costa want to know that I have named it as a beneficiary in my estate plans?

A When a generous donor includes Meals on Wheels of Contra in their will or estate plans, we want to have the opportunity to thank them for their heartfelt gesture by acknowledging them through our exclusive Meals on Wheels Legacy Society. Knowing about future planned gifts also helps us plan for growth to meet the growing needs of our community.

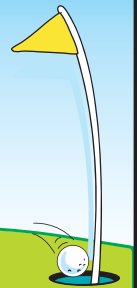

"Meals on Wheels" in Contra Costa County has two flat tires—needs help

A local community group that provides the meals delivered to homebound seniors throughout the county could use some help of its own. Their need is often desperate by the time Meals on Wheels receives a first call for help, but 200 fewer Contra Costa County homebound elders will receive the daily nourishment they need from Meals on Wheels deliveries starting this year. Additionally, for the first time, the Meals on Wheels program has waiting lists of 70 or more homebound elders each day who need Meals on Wheels but who can't be served.

Decreased funding and community donations are causing Meals on Wheels to significantly decrease the number of available meals and perhaps even reduce the number of daily delivery routes. Over 60% of Meals on Wheels Program funding comes from the charitable contributions by individual donors, foundation grants and from the Meals on Wheels Program participants themselves. Each of these revenue sources have either declined significantly, or failed to keep pace with an ever expanding need in the community.

Community contributions to Meals on Wheels of Contra Costa from individuals and charitable foundations are the largest single source of support for Meals on Wheels in Contra Costa County and subsidize virtually all of the 365,000 Meals on Wheels deliveries to nutritionally at-risk homebound elders each year.
